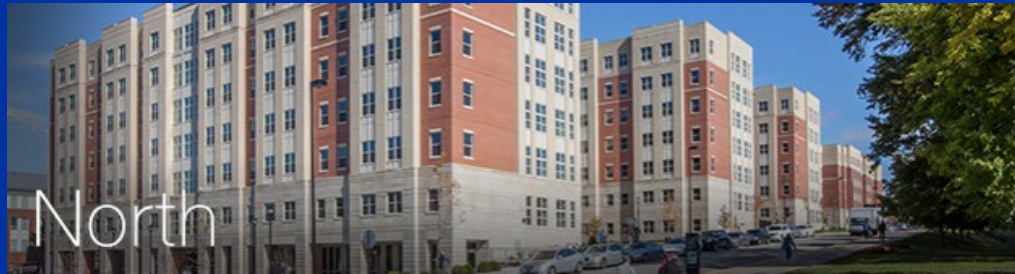

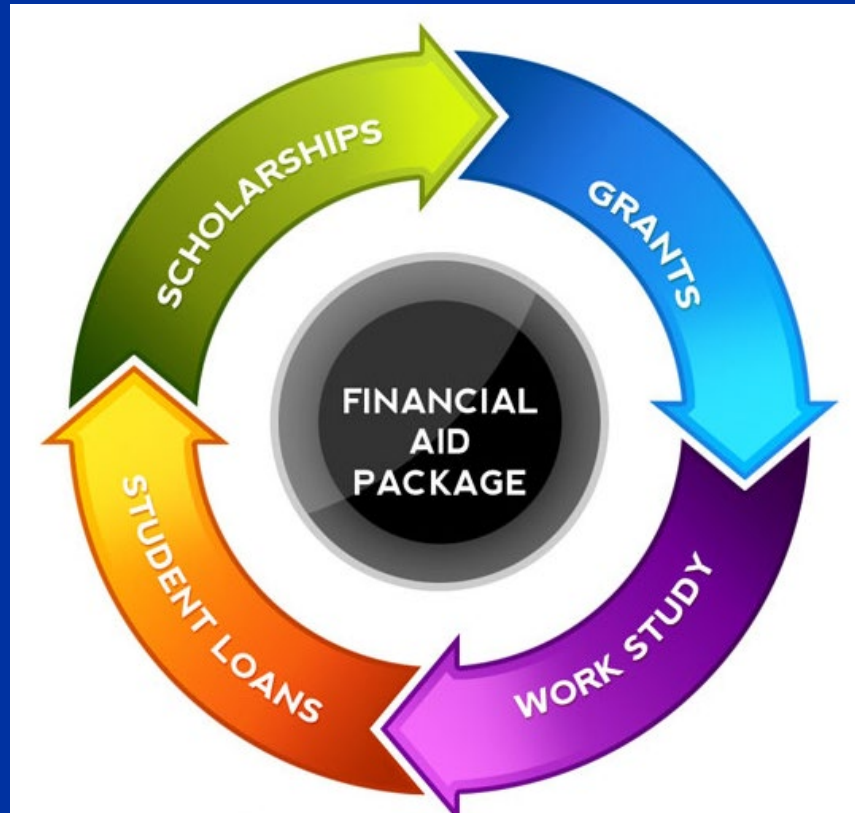

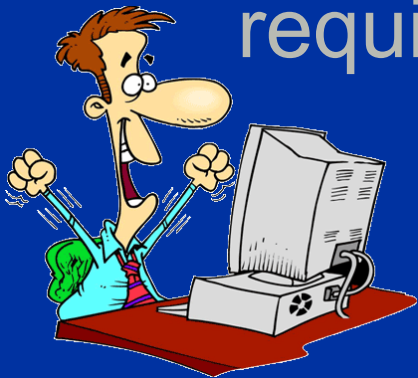

Code to release financial information

- MyPasscode is created by student on myUK
- MyPasscode is shared by student with individual(s) they choose to have access to their financial records
- MyPasscode is **required** prior to release of any financial information

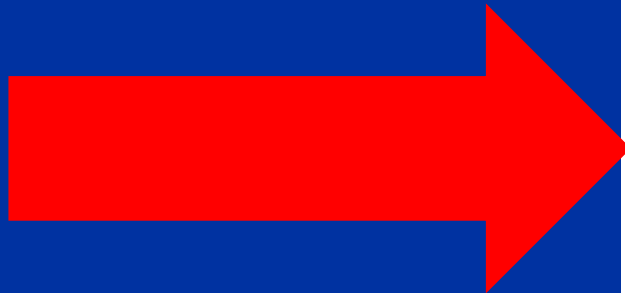

  - Criteria in 13 KAR 2:045, Kentucky's Residency Policy, must be met for a student to be determined a resident for tuition purposes at UK.
